1. Rules

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS) and the rules of the International Star Class Yacht Racing Associatation (STCR).

- 1.1 Decisions of the International Jury will be final in accordance with RRS70.4
- 1.2 Appendix P will apply.
- 1.3 The prescriptions of the national authority, DSV ,shall not apply.
- 1.4 RRS 32 will be changed to provide that courses will not be shortened.
- 1.5 RRS 33b will not apply.
- 1.6 RRS 35 will be changed to provide that boats not finishing within 30 minutes after
 the first boat to finish will be scored "Did Not Finish" without hearing.
- 1.7 RRS 62.2 and 66 will be changed. On the last day of racing the time for requesting redress and the requesting that a hearing be re-opened will be 30 minutes.
- 1.8 RRS A4.1 will be changed to provide that a boat failing to check in prior to the warning signal will be scored the same as a boat not starting in that race without hearing.

2. Advertising

Advertising must comply with ISAF Regulation 20. Boats will be required to display Event Advertising of our sponsor MUSTO on the forward part of the hull. Advertising for tobacco products and alcoholics is explicitly prohibited.

3. Eligibility and Entry Qualifications

- 3.1 Entries eligible in accordance with STCR 21, 26, 28.2, 28.3 and 30 are entitled to compete. According to STCR 29.5 only "Active Members" and "Life Members" of the District 17 are entitled to race.
- 3.2 Entries shall be submitted on the Official Entry Form together with a copy of the valid third party liability (see item 8. Insurance) not later than Juni 11, 2014 to the Augsburger Segler Club. In parallel one copy of the entry form must be sent to the District Secretary Jürgen Janson, E-Mail: jjanson@t-online.de, FAX 0049 (0) 89 60850005. Competitors must be eligible to compete in an event according ISAF Code 19.
- 3.3 Only skippers and crew eligible to compete under the Eligibility Code, RRS, Regulattion 19,shall be eligible to compete in this regatta.
- 3.4 For the purpose of RRS A Scoring: A competitor is not considered an entry until: (a) All fees are paid and (b) Measurement is completed.

4. Fees

The entry fee of 180 € includes boat and trailer parking, launching, hauling and invitations to specified social events for skipper and crew. Entry fee is to be submitted to the Augsburger Segler - Club (Account No. 22 341 481, Sparkasse Landsberg-Diessen, BLZ 700 520 60, IBAN: DE 11 700 520 600 022 341 481, SWIFT-BIC:BYLADEM1LLD)

5. Schedule of Races

The District Championship shall consist of 8 completed races of which 3 races shall be completed to constitute the series.

3 races may be sailed on the same day.

No warning signal will be made after approximately 15:00 hours on Sunday, June 22.

6. Measurement

6.1 Measurement will take place at Augsburger Segler - Club according to the STCR.

Each participating boat shall have a valid Measurement Certificate in the current owners name, and Weight Certificate.

Only boats that have completed registration, paid all entry fees and passed prescribed measurement check procedure by 12:00 hours on Thursday, June 19, are entitled to race.

The International Jury may order that a boat will be rechecked during the regatta.

6.2 Crews shall demonstrate compliance with crew weight limit in accordance with STCR 31.1.3 prior to 12:00 hours on Thursday, June 19.

Crews may be re-weighed during the event at the discretion of the Organizing Authority.

- 6.3 Each Mainsail shall show the Sail number as indicated on the Entry Form and approved by the Measurer.
- 6.4 Bow numbers will be assigned and given to each participating boat. They shall be affixed to the hull according to the Sailing Instructions.

7. Sailing Instructions

The Sailing Instructions will be available from Wednesday, June 18, 14:00 hours in the regatta office.

8. Venue

Racing will be conducted in the waters of Ammersee.

9. Courses

Courses and procedures will be according to the Sailing Instructions of the Augsburger Segler - Club.

10. Scoring

The Low Point Scoring System, RRS A, will apply, modified so that each series score will be the total of her races scores with her worst score excluded if more than four (4) races are completed.

11. Berthing and Hauling

Boats shall be floating at the assigned berth of the Augsburger Segler -Club commencing at 12:00 hours on Thursday June 19, 2014 until the conclusion of racing.

During the competition howling-out is only allowed with the permission of the Organizing Authority.

12. Prizes

- **12.1** Prizes spend by the Augsburger Segler-Club for helmsmen and crews of boats scoring overall on the first third of the fleet.
- 12.2 Masters Scoring

In the frame of the District Championship a Masters scoring (former "100-jährige") will be established. Three perpetual prizes will be awarded.

Requirements:

- Scoring shall be performed upon all eligible races of the District Championship.
- Age of helmsman 50 years minimum (year of birth)
- Age of crew and helmsman must cumulate up to 100 years minimum
- The year of birth of both helmsman and crew must be indicated in the entry form if participation on the Masters scoring is desired.

13. Disclaimer

The Organising Authority will require each competitor to sign a waiver for loss, damage or injury to persons or property occurring in conjunction with regatta or the property of Augsburger Segler - Club. The Organising Authority, their members, employees, officers and/or agents shall not be responsible for any loss, damage or injury that may occur to person or property whether ashore or at sea as a consequence of the participation of any boat.

14. Insurance

A valid third party liability, covering a minimum value of \leq 1.5 Mio is necessary for each participating boat. Such insurance should cover all risks arising whilst the competitor is participating in any way in the championship.

The owner / competitor is required by the organising authority to produce evidence of such insurance by original or copy.
